Love 30, the Campaign for 30 km/h Speed Limits, welcomes the general proposed reduction in speed limits brought about by the Road Traffic Act 2024 and supports Galway County Council's proposed special speed limit bye-laws 2024.

Implementing lower speed limits on rural roads will bring numerous benefits to the County, including enhanced safety, environmental sustainability, and overall quality of life.

1. Improved Road Safety

Lowering speed limits on rural roads is a crucial step towards reducing the number and severity of traffic collisions. Rural roads often have sharp bends, narrow lanes, and limited visibility, making them particularly hazardous at higher speeds. RSA collision data shows that between

2018 and 2021, 38% of road fatalities occurred on 80Km/h roads and 30% of serious injuries. By reducing speed limits on these roads, we can significantly decrease the risk of collisions, thereby protecting the lives of drivers, passengers, cyclists, and pedestrians.

2. Environmental Benefits

Reducing speed limits can also contribute to environmental sustainability. Lower speeds typically result in reduced fuel consumption and lower emissions of greenhouse gases and pollutants. This change aligns with Ireland's target of reducing emissions from the transport sector by between 42% and 50% by 2030.

3. Enhanced Quality of Life

Lower speed limits can improve the quality of life for residents living near rural roads. Reduced traffic noise and vibrations will create a more peaceful and pleasant environment. Additionally, safer roads encourage more walking and cycling, promoting healthier lifestyles and fostering a greater sense of community.

4. Economic Advantages

Safer roads can lead to economic benefits as well. Fewer collisions mean lower costs related to emergency services, medical care, and vehicle repairs. Moreover, a safer and more attractive rural environment can boost local tourism and support small businesses.

5. Specific concerns:

Presentation and format of the bye-laws

The draft bye-laws appear overly-complicated.

- Having multiple sets of bye-laws (2014, 2018, 2019, 2020, 2021, 2024 x2) covering the same location at the same time is confusing and error-prone.
- Re-using old maps that don't match the new text is poor practice and makes it difficult to assess the proposed bye-laws.
- The drawing content, background maps, title blocks and legends on most of the drawings are partly illegible.
- The public consultation documents on speedlimits.ie¹ are different to the public

consultation documents on galway.ie², which in turn are different from the documents on consult.galway.ie³.

80 km/h roads

There are a number of locations where an 80 km/h speed limit is proposed on a road that passes a school, e.g.

- L3124 which passes Presentation College, Athenry
- L348 which passes Clarin College, Athenry

It is not appropriate to have a speed limit of 80 km/h on a road that passes a school. A speed limit of at most 50 km/h should be applied, to make it safer for pupils crossing to the school, and to reduce noise and air pollution in the vicinity of the school. The council should ensure that a maximum speed limit of 50 km/h applies on the sections of roads outside all rural schools.

30 km/h roads

We welcome the proposed introduction of 30km/h speed limits in more housing estates. However it is difficult to determine if all housing estates have been included. Given that the Road Traffic Act 2024 has changed the default urban speed limit to 30 km/h this speed limit should be extended to all housing estates.

We also welcome the proposed introduction of periodic special speed limits outside schools. However we note that there is a mixture of 30 km/h, 50 km/h and 60 km/h outside different schools, that the operational time periods are very limited, and the special speed limit only applies to approx 300 metres of road. Where schools are in urban areas, a speed limit of 30 km/h should be applied to the main routes to the school to enable children to safely walk and cycle to school.

A speed limit of 60 km/h outside Coldwood National School is unacceptable. Research shows that 90% of pedestrians hit by a car traveling at 60 km/h will be killed.

Appendix A - Bye-Laws 1

<u>General</u>

- 1. Should the phrases "legal urban boundary" and "southern border of the legal urban boundary" read "former town boundary"?
- 2. Only one set of bye-laws should be passed. A translation can then be provided *afterwards*. Attempting to pass two sets of parallel bye-laws, in different languages, is error prone
- 3. Are measurements taken along centre lines? This is not stated.
- 4. There are formatting issues throughout the document, which make it harder to read. These include:
 - a. There are multiple changes in font and font size, bold, underline and italic, some of which might not be intended.
 - b. Indents, tabbing and alignment appears to be off in places, e.g. reference numbers are further right than some text.
 - c. In the documents, road numbers are variously given in the style of "L99999" and "L-9999-9". There should be absolute consistency in the style used.
 - d. There is variable use of short and long hyphens –, with and without spaces. These should be standardised.
 - e. On the drawings and in the bye-law text, use the SI unit km/h instead of kph.

- 1. Repeated use if the phrase "The residential areas of" is problematic, especially if any parts of those roads have a non-residential use, e.g. a crèche, school or shops⁹. Simply deleting the phrase or using "The following roads" or similar would be much more appropriate.
- 2. Is it correct that each of the schools has nearly identical opening hours?
- 3. Are measurements taken along centre lines? This is not stated.
- 4. There are formatting issues throughout the document, which make it harder to read. These include:
 - a. There are multiple changes in font and font size, bold, underline and italic, some of which might not be intended.
 - b. Indents, tabbing and alignment appears to be off in places, e.g. reference numbers are further right than some text.
 - c. On the drawings and in the bye-law text, use the SI unit "km/h" instead of "kph".
 - d. In the documents, road numbers are variously given in the style of "9999", "L9999" and "L-9999". There should be absolute consistency in the style used.
 - e. References numbers in lists start at seemingly random numbers. The document hierarchy is NOT clear. It might be made clearer by giving each volume a new page to itself and revising the capitalisation and underlining of titles.
 - f. There is variable use of short and long hyphens –, with and without spaces, and with and without colons. These should be standardised.
- 5. It would be helpful to put the lists of roads in alphabetical or some other logical order.
